

4. Alfiya Battalova

Alfiya Battalova was introduced to the Committee. Alfiya is a post-doctoral student at UBC who will be conducting a project focussing on how accessibility advisory committees function and their role in municipal policy making from the perspectives of the people

6. Role of ACDI in the Municipal World

6.1. History

Members were provided with a brief overview of the Committee's history, including the establishment of the Committee in 1989 by DNV Mayor Baker.

6.2. Introduction to the Committee (Terms of Reference)

A summary of the purpose of the Committee was provided as follows:

- Provide a forum for discussion of issues affecting people with all types of disabilities
- To make recommendations to the three North Shore municipalities to "promote, develop and sustain an accessible community, free of physical and social barriers."
- To organize or participate in community events or awareness activities

The staff representatives on ACDI are non-voting and are from each of the three municipalities. Staff are available to help members on any issues related to the Committee, to take matters to other staff, provide resources and serve as an advocacy/advisory role.

The Councillor members on ACDI are non-voting and are from each of the three municipalities. Members were invited to contact Councillors on any questions or issues.

The Committee's Clerk is also available to assist members.

- Planned to audit a CNV park last year, however this was suspended because of the COVID-19 pandemic.
- Will review the COVID-19 situation at the May or June meeting to determine whether the park audit will go ahead this year or if an alternative format could be organized.

8. Business Arising

8.1. Election of Executives

The Executive of the Committee is comprised of the Chair, Vice-Chair and two additional members who may be called upon for decisions. Members were requested to volunteer to fill the remaining two spots, and accordingly Louisa Bridgman and Juan Palacio were acclaimed into the positions.

9. Subcommittee Reports

- 9.1. Transportation & Mobility
 - Esplanade Complete Street

On review of the report, it was suggested that as this project is still at an early stage, the report will be taken back for further updating and addressed at another meeting.

- 9.2 Development & Inclusion
 - Horseshoe Bay Local Area Plan

Members reviewed and discussed the Horseshoe Bay Local Area Plan as prepared by the Development & Inclusion subcommittee.

MOVED BY Riva Nelson and seconded by Bridgman seconded:

The ACDI is pleased to have been asked to consult on the accessibility of the Horseshoe Bay Local Area Plan - District West Vancouver (DWV). The Committee urges the project proponents to adopt the recommendations listed above, which will improve the overall accessibility of the project, prior to advancing the plan to the DWV council. The ACDI requests a response/update regarding the recommendations that were and were not able to be incorporated within 60 days.

As well within 60 days, the Committee requests to receive an update from relevant staff on the Horseshoe Bay Streetscape Design Project.

Also within 60 days, since the ACDI's previous park audit of the Horseshoe Bay Waterfront Park was undertaken many years ago, the Committee requests to receive an update from Park staff on this portion of the project. CARRIED

10. Other Business and Correspondence

Words Matter

Information was provided on the Words Matter document currently used by the Committee. The document was created for clarity around language and defines respectful language to use around disability. It was noted that although the document needs updating, it is currently used by such organization as Translink, BC Ferries, Arts Club and others. The document provides some guiding principles around language for communications, publications, etc. Once the document is updated, it will be shared and staff and Council will be encouraged to share the document.

- 10.1. Accessibility Issues in Front of Council
 - District of North Vancouver

Work is underway on action planning for the targeted Official Community Plan review and there will be public engagement shortly and a general opportunity for everyone to be involved.

There will be a virtual public hearing on Tuesday, March 2, 7:00 pm for a proposed 60-unit project in the Norgate neighborhood for women experiencing

violence. Information was requested on the percentage of housing for level 1 and Level 2.

Action: Staff will look into getting the information and report back.

Transit is contemplating some changes in the Handy Dart service and Sara Ross will be invited to present or provide information on potential changes to the Committee.

• City of North Vancouver

Members were requested to volunteer to meet on site on Lonsdale to provide feedback on how to design the ramps being used to access the parking lane as well as turning the old conventional parking stalls into accessible temporary parking. On discussion, it was suggested that it may be more beneficial for members if this item to be brought to a subcommittee instead of meeting onsite.

The Esplanade Complete Street project will be brought back to ACDI once there are further designs.

The Kings Mill Walk project, once started, will also be brought to ACDI. There will be a Kings Mill Committee and it may be beneficial for a member of ACDI to sit on that Committee and report back to ACDI.

Council gave Third Reading to a zoning application at 145 – 153 East 4th for a 69unit building, with 19 units meeting the Level 2 design guidelines.

• District of West Vancouver

Alexis Chicoine provided a summary of items in front of Council, and no further report was provided by staff.

11. Advisory Design Panel Update

Alexis Chicoine reported that the District of North Vancouver brought forward the Delbrook affordable housing building that will go up in front of the tennis courts.
