1. Welcome & Introductions

The Chair called the meeting to order at 5:00 pm.

Members were welcomed and provided a brief introduction.

2. Adoption of Agenda

Cllr Lambur moved and Trustee Tsiakos seconded To adopt the agenda.

4. Financial Update 2022

Cristina Rucci provided an overview of the 2022 financial report. The North Shore Standing Committee on Substance Use has two accounts which the City of North Vancouver manages: an Implementation Account and a Project Account. The Project Account consists of monies previously contributed by Vancouver Coastal Health (VCH) to the former North Shore Substance Abuse Task Force. The Implementation Account consists of monies that have been contributed by member organizations other than VCH. Records back to 2003 indicate that contributing organizations have included the City of North Vancouver, the Districts of North and West Vancouver, the Villages of

Lions Bay and Bowen Island, and School Districts #44 & #45. Organizations deposited arbitrarily determined amounts based upon the required budget. Expenses are paid out from the account and apportioned against the member deposits. Surplus deposits are carried over from year to year.

Since 2006 only the City of North Vancouver (CNV), and the District of North Vancouver (DNV), and the

It was recently discovered that due to an oversight, there was now a shortfall in District of West Vancouver's portion of the Implementation Account. In this regard, members were requested to consider whether there was interest in using some of the funds in the Project Account to cover the committee meeting expenses. On discussion, it was suggested that this issue be re-addressed at the end of the meeting.

The balance of the Implementation Account at January 1, 2022 was \$5,534.97 and the balance of the Project Account was \$14,445.81.

5. VCH Presentation

Elizabeth Holliday, Operations Director, Overdose Emergency Response and Harm Reduction provided a presentation on the Vancouver Coastal Health Overdose Emergency Response which included the following:

- Overdose data including VCH-wide and North Shore specific information
- Current/new Overdose Emergency Response initiatives
- Update on provincial decriminalization initiative
- Update on Safer Supply and Nurse Prescribing

6. Discussion and Follow Up on Letter in Support of Legalization and Regulation

As background, in 2021 a letter to the Federal government was drafted with a motion requesting an amendment to the statutes to create a scheme of full legalization and regulation of all illicit substances as an urgent public health measure.

On review and discussion of the proposed letter and motion, it was suggested to include updated data, and some information around the compassion club model as a potential interim measure to legalization.

During the discussion, a concern was raised that not all the members and various stakeholders of the committee were present to provide their input and feedback on the proposed letter.

Action: Staff will update and circulate the letter to the Committee, and then forward the letter to government.

That the letter as amended be sent to the Federal Government.
