THE CORPORATION OF THE DISTRICT OF NORTH VANCOUVER

By-law No. 1107

A By-law to dedicate certain lands acquired by the Corporation for road purposes as and for a public highway.

WHEREAS the lands and premises hereinafter particularly described have been received and accepted by the Corporation of the District of North Vancouver for road purposes.

AND WHEREAS the Commissioner of the Corporation of the District of North Vancouver deems it expedient to dedicate the said lands and premises to the Crown in right of the Province of British Columbia as and for a highway.

THEREFORE the Commissioner of the Corporation of the District of North Vancouver in exercise of all the powers him thereunto enabling enacts as follows:

(1) The Southerly 33 feet of Blocks D, E, F, and G, in District Lot numbered Six hundred and thirteen (613), Reference Plan Number 165, and Parcel A (Reference Plan 1891) of Block G, District lot numbered Six hundred and thirteen (613), all in Group One, New Westminster District, are hereby dedicated to the Crown in right of the Province of British Columbia as and for a public highway to and for the free use of the public at all times hereafter.

(2) This By-law shall not come into force and effect unless and until it shall have received the approval of the Lieutenant-Governor in Council.

(3) This By-law may be cited for all purposes as the "LANDS DEDICATION BY-LAW NO. 4 1939".

PASSED by the Commissioner of the Corporation of the District of North Vancouver on the 31st day of January 1939.

A bylaw to Amend Bylaw 1107

The Council for The Corporation of the District of North Vancouver enacts as follows:

Citation

1. This bylaw may be cited as "District of North Vancouver Lands Dedication Bylaw 1107 Amendment Bylaw (Bylaw 8509), 2021."

Dedication Removal

2. District of North Vancouver Lands Dedication Bylaw 1107 is hereby amended by removing the dedication for highway of:
 - (a) all of Lot A (Reference Plan 1891) Group 1 NWD Except Part in Explanatory Plan 16854, Block G (Reference Plan 165) District Lot 613; and
 - (b) the portion of Lot B Blocks G and J District Lot 613 Plan 20072 shown on explanatory Plan 16854.


