A presentation was provided on the process for reviewing the grant applications, including review of Goals and Guiding Principals, the Grant Application Screen Criteria as well as a brief review of the financial information.

For this year, all documents relating to the grant process, including the applications, accountability forms and supplemental information will be posted on the District's OwnCloud. Members will be provided with the link to access this platform.

Members were informed of the available budget amount for this year's grant process. In terms of the number of applications, there were 49 applications received this year, compared to 68 applications in 2020. This includes four applications for new programs, one new application for an operating grant, and three applications that are from new organizations to the District.

There was a discussion on last year's reconciliation process, and members indicated that it would be beneficial to have a discussion on the prioritization for the reconciliation prior to the end of this year's grant process. As well, a suggestion was presented that in assessing the applications, members may wish to consider continuing with the usual practice, or to explore the idea of possibly developing a matrix or score card that could be used to rank and weight the different applications.

Action: This discussion will be brought to the next meeting.

A presentation was also provided on the interview process including possible questions to be discussed with the organizations during the interview.

Members were requested to review the Accountability Forms of the organizations in their second year of funding.
