The Committee was requested to consider whether they wished to look at, or explore potentially more equitable ways of assessing the grant applications as well as possibly change the reconciliation process, and some ideas and methods were presented. On discussion, some of the comments provided were as follows:

- For organizations that request operating funding, consider whether they are part of core funding and who are their other funders.
- A score card may be beneficial when ranking and rating similar items; however, a scorecard may not be useful when looking at the diverse nature of the grants.
- When considering the grant applications, perhaps have a mutual understanding to strive for being more judicious.
- Reviewing the guiding principles and the screen criteria and being grounded in the principles and goals of the grant.
- The Committee may wish to pull out 15 components and weight to determine which component is the most important in a grant

In moving forward, the Committee will continue with the discussion and consider whether it may be beneficial to develop some sort of scale for the following year.
